Upskilling Professional Driving Instructors of Young Learner Drivers: What Are We Waiting For?

This driver education research paper has just been published. The key findings are:

- Due to adolescent development, young driver training needs differ to adults
- Young drivers report poor knowledge and use of driver assistance technologies
- Developmentally appropriate training to address young driver needs is demonstrated
- Parents can lack awareness, knowledge or skills to train young drivers optimally
- Driving instructors seek but lack professional development opportunities
- Upskilling driving instructors has potential to upskill young drivers *and* parents

President's Update - No Resit Fees October 2023 - Are You Ready?



Disruption to driver training in New Zealand is due October 2023. It will be the biggest disruption since covid. Worst case, Instructors go out of business. 'Pass the test' rather than 'learn to drive' becomes engrained. Test wait times hit two months. Resit no shows quadruple and the budget to pay for it blows. We're talking no fee resits. No resit fees for the class 1 restricted and full driver licence tests. It was announced April 2023. It will start October 2023. From October, if you fail your restricted or full licence test, there is unlimited resits, no cost. Sounds great from the drivers perspective. Unlimited resits, no cost. Here's the but. The price of the first restricted test will be \$167.57. Right now, it is \$134.80. If that new price forces a choice between a lesson or a test, it will be the test. Free resits will be used to learn. Driver expectations shift to testing officers for training. First time pass rates drop. The financial incentive to avoid a resit is gone.
