Waka Kotahi NZ Transport Agency Lockdown Guidance



For driver training and assessment/testing during Covid lockdown Waka Kotahi say Ministry of Health guidelines and requirements must be followed. Jim Ferneaux advised that in cases where other statutory bodies such as the Ministry of Education or the Tertiary Education Commission have set additional requirements, they must also be followed. These additional requirements might affect approved driver licensing courses, course providers, assessors and testers. For example, if the Tertiary Education Commission restricts a class size that limits the number of people attending an approved course, and that class size reduction will affect the completion of the course for some course participants, then the course provider needs to contact Waka Kotahi ASAP to find a solution. If you are a licensee to a course provider, contact that course provider. For example, Street Talk providers contact Wayne Young or Harald Leeuwenburgh. MITO Driving Unit Standards Five Year Automatic Review

MITO announced this review 31 August 2021. We pushed a notice to NZIDE members and subscribers in September with a summary of feedback. 17 units were identified for change. Responsibility for that change passes from MITO to Hanga-Aro-Rau Manufacturing, Engineering and Logistics Workforce Development Council. Hanga-Aro-Rau is required to consult with an industry stakeholder group. Nick Leggett, council member on Hanga-Aro-Rau, a director at MITO and Chief Executive at la Ara Aotearoa Transporting New Zealand (Road Transport Forum) advised the stakeholder group is yet to be formed. Nick thanked NZIDE for our approach to join this stakeholder group. Hanga-Aro-Rau might also refer to a Centre of Vocational Excellence if one is established for road transport driver education. The next mandatory five year review of unit standards will trigger in September 2026.

Waka Kotahi NZ Transport Agency Waka Kotahi NZ Transport Agency consulted on the Land Transport (Driver Licensing) Amendment Rule (No2) 2021. We pushed notification of this to members. The proposed Rule will revoke the five-year time-limit for the Class 1 and 6 learner and restricted licences, and revert them back to a standard 10-year validity (the same as the full licence) when a licence-holder renews their learner or restricted licence. It will also remove the 90-day time restriction on renewal, allowing these licence holders to renew their licence any time before expiry, and will remove the requirement for the licence holder to re-sit and pass a theory test to renew their licence. Thank you to those who responded. There was split opinion on this. If you would like a copy of the NZIDE submission, let us know.
